The Authors retain the Copyright of their work to be published without restrictions and grant the journal the right of first publication (i.e. the journal shall decide on the time, place, and manner in which the work will be made accessible to the public). At the same time, the author licenses the distribution and availability of his/her work to the public using the Creative Commons open licence that the respective journal has chosen.
- 2. Authors may enter into separate and additional agreements for the nonexclusive reproduction and distribution of their work to the public (e.g. deposit in an academic repository or publication in a book), provided that the author is credited as well as the first publication in this journal.
- 3. The journal permits and encourages authors to self-archive their article online (e.g. in an academic repository or on their personal websites) both before and after the publication processes (preprint and postprint), as this may lead to the productive exchange of ideas and thoughts as well as the faster and
